1. General Provisions

This Public Offer (“Offer”) is an official proposal of Limited Liability Company “MORE DISTRIBUTE” (hereinafter referred to as the “Company”) to conclude an agreement for the use of the ADS PANEL software (hereinafter referred to as the “Software”) by users. The Software is intended for displaying video and graphic advertising materials on THE ADS PANEL devices (models: ads001, ads002, ads003).

2. Acceptance of the Offer

By activating THE ADS PANEL device on the website adspanel.uz through SMS registration and the unique device ID, the User confirms their full agreement with the terms of this Offer. From the moment of device activation, this Offer is considered accepted, and the agreement is deemed concluded.

3. Terms of Use

- 3.1. The User obtains the right to use the ADS PANEL Software to display advertising videos and images on their device.
- 3.2. Use of the Software is provided free of charge (without subscription fees) for a period of 12 (twelve) months from the date of purchase and activation of the device.
- 3.3. After this period, a subscription fee will be charged according to the tariffs published on adspanel.uz.

4. Responsibilities of the Parties

- 4.1. LLC “MORE DISTRIBUTE” is not responsible for the content or nature of the advertising materials displayed on the User’s device.
- 4.2. The User bears full responsibility for all materials they publish, including compliance with the laws of the Republic of Uzbekistan, in particular: the Law “On Advertising”, the Law “On Informatization”, and other applicable legal acts.
- 4.3. The User is strictly prohibited from using the device and Software to display or distribute materials that promote violence, terrorism, prostitution, discrimination, or any other information that violates the laws of the Republic of Uzbekistan.
