1. General Provisions

This Privacy Policy (“Policy”) describes how LLC “MORE DISTRIBUTE” (“the Company”) collects, stores, and protects user data when using the ADS PANEL software and THE ADS PANEL devices (models ads001, ads002, ads003). By registering and activating the device on adspanel.uz, the User agrees to this Policy.

2. Data Collected

The Company may collect the following types of data:

- Device identification: unique ID, serial number;
- Network data: IP address, MAC address, network parameters;
- User data: phone number, name (if provided during registration);
- Geolocation: approximate location based on network data;
- Activity history: system usage logs (settings changes, ad display, error logs);
- Technical parameters: OS version, firmware, device condition.

3. Purpose of Data Processing

Data is collected and processed for:

- Device registration and activation;
- Ensuring proper functioning of software and hardware;
- Improving service quality and technical support;
- Diagnostics and analytics;
- Compliance with legal requirements and protection of the rights of the Company and Users.

4. Cookies and Similar Technologies

The Company may use cookies, web beacons, and similar technologies to:

- Identify users and devices;
- Store user preferences;
- Analyze behavior and improve the service;
- Personalize the user experience.

Users can manage cookies via browser or device settings; disabling some cookies may limit functionality.

5. Data Storage and Security

All data is securely stored on protected servers. Access is limited to authorized personnel. The Company applies encryption, access control, and backup mechanisms. Data is kept only for as long as necessary to fulfill its purposes.

6. Disclosure to Third Parties

The Company does not disclose user data to third parties except:

- When required by law or court order;
- When necessary to fulfill contractual obligations;
- With user consent;
- To service providers (e.g., hosting, maintenance) under confidentiality agreements.

7. User Rights

Users have the right to:

- Access and review their personal data;
- Request corrections or deletions;
- Withdraw consent (which may limit functionality);
- Contact the Company at info@adspanel.uz for privacy matters.

8. Children's Data

The ADS PANEL service is not intended for individuals under 18 years old. If data of minors is discovered without parental consent, it will be deleted immediately.

9. Policy Changes

The Company reserves the right to amend this Policy at any time. Updated versions will be published on adspanel.uz. Continued use of the software implies acceptance of the new terms.
